

# Southern Newfoundland Club Judging Criteria 2022 – Water

### **Introduction:**

- Submitted a written application to Working Section Sub-Committee detailing previous experience and reasons for wishing to judge
- Must have read and understood the Test Regulations
- Keep own record judging experience
- Must apply in writing to the SNCWSC for consideration for promotion from either junior to senior or to higher levels.
- o Judging and stewarding may be at NC, NNC & SNC events
- o Judges and Stewards are expected to attend training days as organized
- o Where more than one event is stipulated, they must be at different venues
- Promotion from Novice to Senior or to next level is subject to approval by the majority at a SNCWSC meeting

## **Section A Qualifications:**

- O Stewarded Sections A & B at a minimum of 2 separate events
- o Handled a dog in Sections A & B at a minimum of 2 events
- o First judging appointment to be with a Section C judge or above

#### For promotion to Senior

- o Receive written recommendation from senior Section B qualified judge or above
- o Judge a minimum of 2 events with a total of 20 dogs as novice judge
- o Conduct judges briefing (entrants & Stewards) at novice level at one event

## **Section B Qualifications:**

- o Handled a dog in a further 2 events at Section B
- o Stewarded Section B at a further two events
- o Judged a minimum of 10 dogs at 2 events as senior judge at Section A
- o Receive written recommendation from senior Section B qualified judge or above
- Must have been a Senior Section A judge at two events

#### For promotion to Senior

- Judge a minimum of 20 dogs at 2 events as novice B judge before being eligible for promotion to senior judge
- o Conduct judges briefing (entrants & Stewards) at novice level at one event
- o Receive written recommendation from senior Section C qualified judge or above

### **Section C Qualifications:**

- Stewarded Section C at two events
- o Judged a minimum of 10 dogs at 2 events as senior Section B Judge
- o Receive written recommendation from senior Section C qualified judge or above
- o Must have been a Senior Section B judge at two events

### For promotion to Senior

- o Judge a minimum of 10 dogs at 2 events as a Novice C judge
- o Conduct judges briefing (entrants & Stewards) at novice level at one event
- o Receive written recommendation from senior Section D qualified judge or above

### **Section D Qualifications:**

- Stewarded Section D at three events
- o Judged a minimum of 10 dogs as a senior Section C Judge
- o Receive written recommendation from senior Section D qualified judge or above
- o Must have been a Senior Section C judge at two events

#### For promotion to Senior

- o Judge a minimum of 10 dogs at 2 events as a Novice D judge before being eligible for promotion to senior judge
- o Conduct judges briefing (entrants & Stewards) at novice level at one event
- o Receive written recommendation from senior Section E qualified judge or above

### **Section E Qualifications:**

- o Stewarded in Section E at three events
- o Judged a minimum of 5 dogs as senior judge at Section D
- o Must have been a Senior Section D judge at two events
- Receive written recommendation from senior Section E qualified judge or above

#### For promotion to Senior

- o Judge a minimum of 1event as novice judge
- o Conduct judges briefing (entrants & Stewards) at novice level at one event
- o Receive written recommendation from senior Section E qualified judge or above
